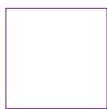

- GDPR Overview
 - The General Data Protection Regulation (GDPR) represents a significant change to data protection and privacy legislation that will result in changes to: 1) how we deal with personal data; and 2) the information governance processes of any organization however mature.
- Management and Oversight of GDPR Requirements
 - GDPR requires the participation of key stakeholders including the creation of the role of the Data Privacy Officer to help manage the GDPR program.
- How to start
 - Establish a project plan for your GDPR program and working group.
 - Assess your data and risk exposure — and the scale of effort required to achieve compliance — through a data visibility assessment.
 - Review the impact of GDPR, and its effect on increasing business risk, on your existing data breach protection and detection mechanisms.
