# 2018 SCCE European Compliance and Ethics Institute Basic Principles for Resolving Difficult Conversation • Clarify the situation • Focuse at the <u>ultimate objective</u> (put your ego aside)

- Look for one common interest
- Start conversation by stressing the ultimate objective and by <u>listening</u> to the other side
- Show understanding of the other side and their reasons
- Reflect, mirror, ask questions
- Use some helpful phrases... but take caution\*
- PREPARATION you are going to be negotiating!

### Practical Framework for Resolving Difficult Conversations

Start by Defining THE ISSUE: all Aspects, Details, Information, Data, Persons involved or interested...

#### YOUR PERSPECTIVE

- Why is this subject matter important to me?
- What interests do I represent or wish to protect?
- What are my objectives for this conversation?
- What am I not willing to compromise and which arguments will I use?
- What is my concerns about the conversation, what do I have to loose?

#### OTHER PARTY'S PERSPECTIVE

- What are other party's interests, why is this important to them?
- What could they be worried about, what do they have to loose?
- What objections and arguments should I expect?
