CORPORATE INTEGRITY AGREEMENT BETWEEN THE OFFICE OF INSPECTOR GENERAL OF THE DEPARTMENT OF HEALTH AND HUMAN SERVICES AND SOUTH MIAMI HOSPITAL, INC.

I. PREAMBLE

South Miami Hospital, Inc. (South Miami Hospital), whose parent corporation is Baptist Health South Florida, Inc. d/b/a Baptist Health South Florida (Baptist), hereby enters into this Corporate Integrity Agreement (CIA) with the Office of Inspector General (OIG) of the United States Department of Health and Human Services (HHS) to promote compliance with the statutes, regulations, and written directives of Medicare, Medicaid, and all other Federal health care programs (as defined in 42 U.S.C. § 1320a-7b(f)) (Federal health care program requirements).

Prior to this CIA, South Miami Hospital has represented that it voluntarily participated in Baptist's Compliance Program that includes a Chief Compliance Officer; Code of Ethics; compliance training and education; a confidential disclosure reporting hotline; exclusion screening; a risk assessment process; a Compliance Committee; auditing and monitoring activities and various policies, procedures, and guidance that seek to ensure compliance with Federal health care program requirements. Contemporaneously with this CIA, South Miami Hospital is entering into a Settlement Agreement with the United States.

II. TERM AND SCOPE OF THE CIA

- A. The period of the compliance obligations assumed by South Miami Hospital under this CIA shall be five years from the effective date of this CIA. The "Effective Date" shall be the date on which the final signatory of this CIA executes this CIA. Each one-year period, beginning with the one-year period following the Effective Date, shall be referred to as a "Reporting Period."
- B. Sections VII, X, and XI shall expire no later than 120 days after OIG's receipt of: (1) South Miami Hospital's final Annual Report or (2) any additional materials submitted by South Miami Hospital pursuant to OIG's request, whichever is later.

C. For purposes of this CIA, the term "Covered Persons" includes: (1) all owners, officers, directors, and employees of South Miami Hospital; (2) all contractors, subcontractors, agents, and other persons who furnish patient care items or services or who perform billing or coding functions on behalf of South Miami Hospital, excluding vendors whose sole connection with South Miami Hospital is selling or otherwise providing medical supplies or equipment to South Miami Hospital; and (3) all physicians and other non-physician practitioners who are members of South Miami Hospital's active medical staff.

Notwithstanding the above, this term does not include part-time or per diem employees, contractors, subcontractors, agents, and other persons who are not reasonably expected to work more than 160 hours during a Reporting Period, except that any such individuals shall become "Covered Persons" at the point when they work more than 160 hours during a Reporting Period.

III. CORPORATE INTEGRITY OBLIGATIONS

South Miami Hospital shall establish and maintain a Compliance Program that includes the following elements:

- A. <u>Hospital Compliance Officer and Committee, Board of Directors, and Management Compliance Obligations</u>
- Date, South Miami Hospital shall appoint a facility-based Hospital Compliance Officer and shall maintain a Hospital Compliance Officer for the term of the CIA. The Hospital Compliance Officer shall be an employee and a member of senior management of South Miami Hospital, and shall report directly to the Corporate Vice President and Chief Compliance Officer of Baptist and the South Miami Hospital Board of Directors. The Hospital Compliance Officer shall not be or be subordinate to the General Counsel or the South Miami Hospital Controller or have any responsibilities that involve acting in any capacity as legal counsel or supervising legal counsel functions for South Miami Hospital. The Hospital Compliance Officer shall be responsible for, without limitation:
 - a. developing and implementing policies, procedures, and practices designed to ensure compliance with the requirements set forth in this CIA and with Federal health care program requirements;

- b. making periodic (at least quarterly) reports regarding compliance matters directly to the Board of Directors of South Miami Hospital and shall be authorized to report on such matters to the Board of Directors at any time. Written documentation of the Hospital Compliance Officer's reports to the Board of Directors shall be made available to OIG upon request; and
- c. monitoring the day-to-day compliance activities engaged in by South Miami Hospital as well as any reporting obligations created under this CIA.

Any noncompliance job responsibilities of the Hospital Compliance Officer shall be limited and must not interfere with the Hospital Compliance Officer's ability to perform the duties outlined in this CIA.

South Miami Hospital shall report to OIG, in writing, any changes in the identity of the Hospital Compliance Officer, or any actions or changes that would affect the Hospital Compliance Officer's ability to perform the duties necessary to meet the obligations in this CIA, within five days after such a change.

2. Hospital Compliance Committee. Within 120 days after the Effective Date, South Miami Hospital shall appoint a facility-based Hospital Compliance Committee. The Hospital Compliance Committee shall, at a minimum, include the Hospital Compliance Officer and other members of senior management necessary to meet the requirements of this CIA (e.g., senior executives of relevant departments, such as billing, clinical, human resources, audit, and operations). The Hospital Compliance Officer shall chair the Hospital Compliance Committee and the Committee shall support the Hospital Compliance Officer in fulfilling his/her responsibilities (e.g., shall assist in the analysis of South Miami Hospital's risk areas and shall oversee monitoring of internal and external audits and investigations). The Hospital Compliance Committee shall meet at least quarterly. The minutes of the Hospital Compliance Committee meetings shall be made available to OIG upon request.

South Miami Hospital shall report to OIG, in writing, any actions or changes that would affect the Hospital Compliance Committee's ability to perform the duties necessary to meet the obligations in this CIA, within 15 days after such a change.

3. Board of Directors Compliance Obligations. The Board of Directors (or a committee of the Board) of South Miami Hospital (Board) shall be

responsible for the review and oversight of matters related to compliance with Federal health care program requirements and the obligations of this CIA. The Board must include independent (i.e., non-executive) members.

The Board shall, at a minimum, be responsible for the following:

- a. meeting at least quarterly to review and oversee South Miami Hospital's compliance program, including but not limited to the performance of the Hospital Compliance Officer and Hospital Compliance Committee;
- b. submitting to OIG a description of the documents and other materials it reviewed, as well as any additional steps taken, such as the engagement of an independent advisor or other third party resources, in its oversight of the compliance program and in support of making the resolution below during each Reporting Period;
- c. for each Reporting Period of the CIA, adopting a resolution, signed by each member of the Board summarizing its review and oversight of South Miami Hospital's compliance with Federal health care program requirements and the obligations of this CIA; and
- for each Reporting Period of the CIA, the Board shall retain d. an individual or entity with expertise in compliance with Federal health care program requirements (Compliance Expert). The Compliance Expert shall perform a review of the effectiveness of South Miami Hospital's Compliance Program (Compliance Program Review) in the first and fourth Reporting Periods. The Compliance Expert shall create a work plan for the Compliance Program Review and prepare a written report about the Compliance Program Review. The written report (Compliance Program Review Report) shall include a description of the Compliance Program Review and any recommendations with respect to South Miami Hospital's compliance program. The Board shall review the Compliance Program Review Report as part of its review and oversight of South Miami Hospital's compliance program. A copy of the Compliance Program

Review report shall be provided to OIG in the applicable Annual Reports submitted by South Miami Hospital. In addition, copies of any materials provided to the Board by the Compliance Expert, along with minutes of any meetings between the Compliance Expert and the Board, shall be made available to OIG upon request.

At minimum, the resolution shall include the following language:

"The Board of Directors has made a reasonable inquiry into the operations of South Miami Hospital's Compliance Program, including the performance of the Hospital Compliance Officer and the Hospital Compliance Committee. Based on its inquiry and review, the Board has concluded that, to the best of its knowledge, South Miami Hospital has implemented an effective Compliance Program to meet Federal health care program requirements and the obligations of the CIA."

If the Board is unable to provide such a conclusion in the resolution, the Board shall include in the resolution a written explanation of the reasons why it is unable to provide the conclusion and the steps it is taking to implement an effective Compliance Program at South Miami Hospital.

South Miami Hospital shall report to OIG, in writing, any changes in the composition of the Board, or any actions or changes that would affect the Board's ability to perform the duties necessary to meet the obligations in this CIA, within 15 days after such a change.

4. Management Certifications. In addition to the responsibilities set forth in this CIA for all Covered Persons, certain South Miami Hospital employees (Certifying Employees) are expected to monitor and oversee activities within their areas of authority and shall annually certify that the applicable South Miami Hospital department is in compliance with applicable Federal health care program requirements and the obligations of this CIA. These Certifying Employees shall include, at a minimum, the following: Chief Executive Officer, Vice President and Chief Nursing Officer, Chief Medical Officer, Vice President of Operations, the Vice President for the Center for Women and Infants, the Assistant Vice President, Quality, Performance Improvement, the Assistant Vice President, Perinatal Services, the Assistant Vice President, Peri-Operative Services, the Assistant Vice President, Neonatal Services, the Assistant Vice President, Operations, and the Assistant Vice President, Nursing. For each Reporting Period, each Certifying Employee shall sign a certification that states:

"I have been trained on and understand the compliance requirements and responsibilities as they relate to [insert name of department], an area under my supervision. My job responsibilities include ensuring compliance with regard to the [insert name of department] with all applicable Federal health care program requirements, obligations of the Corporate Integrity Agreement, and South Miami Hospital policies, and I have taken steps to promote such compliance. To the best of my knowledge, the [insert name of department] of South Miami Hospital is in compliance with all applicable Federal health care program requirements and the obligations of the Corporate Integrity Agreement. I understand that this certification is being provided to and relied upon by the United States."

If any Certifying Employee is unable to provide such a certification, the Certifying Employee shall provide a written explanation of the reasons why he or she is unable to provide the certification outlined above.

Within 120 days after the Effective Date, South Miami Hospital shall develop and implement a written process for Certifying Employees to follow for the purpose of completing the certification required by this section (e.g., reports that must be reviewed, assessments that must be completed, sub-certifications that must be obtained, etc. prior to the Certifying Employee making the required certification).

B. Written Standards

Within 120 days after the Effective Date, South Miami Hospital shall develop and implement written policies and procedures regarding the operation of its compliance program, including the compliance program requirements outlined in this CIA and South Miami Hospital's compliance with Federal health care program requirements (Policies and Procedures). Throughout the term of this CIA, South Miami Hospital shall enforce its Policies and Procedures and shall make compliance with its Policies and Procedures an element of evaluating the performance of all employees. The Policies and Procedures shall be made available to all Covered Persons.

At least annually (and more frequently, if appropriate), South Miami Hospital shall assess and update, as necessary, the Policies and Procedures. Any new or revised Policies and Procedures shall be made available to all Covered Persons.

All Policies and Procedures shall be made available to OIG upon request.

C. Training and Education

- Date, South Miami Hospital shall develop a written plan (Training Plan) that outlines the steps South Miami Hospital will take to ensure that all Covered Persons receive at least annual training regarding South Miami Hospital's CIA requirements and Compliance Program and the applicable Federal health care program requirements, including the requirements of the Anti-Kickback Statute and the Stark Law. The Training Plan shall include information regarding the following: training topics, categories of Covered Persons required to attend each training session, length of the training session(s), schedule for training, and format of the training. South Miami Hospital shall furnish training to its Covered Persons pursuant to the Training Plan during each Reporting Period. The Training Plan shall include the Board Member Training, as required in Section III.C.2.
- 2. Board Member Training. Within 120 days after the Effective Date, each member of the South Miami Hospital Board of Directors shall receive at least two hours of training. This training shall address the corporate governance responsibilities of board members, and the responsibilities of board members with respect to review and oversight of the Compliance Program. Specifically, the training shall address the unique responsibilities of health care Board members, including the risks, oversight areas, and strategic approaches to conducting oversight of a health care entity. This training may be conducted by an outside compliance expert hired by the Board and should include a discussion of the OIG's guidance on Board member responsibilities.

New members of the Board of Directors shall receive the Board Member Training described above within 30 days after becoming a member or within 120 days after the Effective Date, whichever is later.

- 3. Training Records. South Miami Hospital shall make available to OIG, upon request, training materials and records verifying that Covered Persons and Board members have timely received the training required under this section.
- 4. Computer-based Training. South Miami Hospital may provide the training required under this CIA through appropriate computer-based training approaches. If South Miami Hospital chooses to provide computer-based training, it shall make available appropriately qualified and knowledgeable staff or trainers to answer questions or provide additional information to the individuals receiving such training.

D. Review Procedures

1. General Description

- a. Engagement of Independent Review Organization. Within 120 days after the Effective Date, South Miami Hospital shall engage an entity (or entities), such as an accounting, auditing, or consulting firm (hereinafter "Independent Review Organization" or "IRO"), to perform the reviews listed in this Section III.D. The applicable requirements relating to the IRO are outlined in Appendix A to this CIA, which is incorporated by reference.
- b. Retention of Records. The IRO and South Miami Hospital shall retain and make available to OIG, upon request, all work papers, supporting documentation, correspondence, and draft reports (those exchanged between the IRO and South Miami Hospital) related to the reviews.
- 2. Claims Review. The IRO shall review claims submitted by South Miami Hospital and reimbursed by the Medicare, state Medicaid, and TRICARE programs, to determine whether the items and services furnished were medically necessary and appropriately documented and whether the claims were correctly coded, submitted and reimbursed (Claims Review) and shall prepare a Claims Review Report, as outlined in Appendix B to this CIA, which is incorporated by reference.
- 3. Independence and Objectivity Certification. The IRO shall include in its report(s) to South Miami Hospital a certification that the IRO has (a) evaluated its professional independence and objectivity with respect to the reviews required under this Section III.D and (b) concluded that it is, in fact, independent and objective, in accordance with the requirements specified in Appendix A to this CIA. The IRO's certification shall include a summary of all current and prior engagements between South Miami Hospital and the IRO.

E. Risk Assessment and Internal Review Process

Within 120 days after the Effective Date, South Miami Hospital shall develop and implement a centralized annual risk assessment and internal review process to identify and address risks associated with South Miami Hospital's participation in the Federal health care programs, including but not limited to the risks associated with the

submission of claims for items and services furnished to Medicare, state Medicaid, and TRICARE program beneficiaries. The risk assessment and internal review process shall require compliance, legal, and department leaders, at least annually, to: (1) identify and prioritize risks. Based upon results of the risk assessment, the Hospital Compliance Officer shall: (1) develop internal audit work plans related to the identified risk areas, (2) implement the internal audit work plans, (3) develop corrective action plans in response to the results of any internal audits performed, and (4) track the implementation of the corrective action plans in order to assess the effectiveness of such plans. South Miami Hospital shall maintain the risk assessment and internal review process for the term of the CIA.

F. Disclosure Program

To the extent not already accomplished, within 120 days after the Effective Date, South Miami Hospital shall establish a Disclosure Program that includes a mechanism (e.g., a toll-free compliance telephone line) to enable individuals to disclose, to the Hospital Compliance Officer or some other person who is not in the disclosing individual's chain of command, any identified issues or questions associated with South Miami Hospital's policies, conduct, practices, or procedures with respect to a Federal health care program believed by the individual to be a potential violation of criminal, civil, or administrative law. South Miami Hospital shall appropriately publicize the existence of the disclosure mechanism (e.g., via periodic e-mails to employees or by posting the information in prominent common areas).

The Disclosure Program shall emphasize a nonretribution, nonretaliation policy and shall include a reporting mechanism for anonymous communications for which appropriate confidentiality shall be maintained. The Disclosure Program also shall include a requirement that all of South Miami Hospital's Covered Persons shall be expected to report suspected violations of any Federal health care program requirements to the Hospital Compliance Officer or other appropriate individual designated by South Miami Hospital. Upon receipt of a disclosure, the Hospital Compliance Officer (or designee) shall gather all relevant information from the disclosing individual. The Hospital Compliance Officer (or designee) shall make a preliminary, good faith inquiry into the allegations set forth in every disclosure to ensure that he or she has obtained all of the information necessary to determine whether a further review should be conducted. For any disclosure that is sufficiently specific so that it reasonably: (1) permits a determination of the appropriateness of the alleged improper practice; and (2) provides an opportunity for taking corrective action, South Miami Hospital shall conduct an internal

review of the allegations set forth in the disclosure and ensure that proper follow-up is conducted.

The Hospital Compliance Officer (or designee) shall maintain a disclosure log and shall record each disclosure in the disclosure log within two business days of receipt of the disclosure. The disclosure log shall include a summary of each disclosure received (whether anonymous or not), the status of the respective internal reviews, and any corrective action taken in response to the internal reviews.

G. <u>Ineligible Persons</u>

- 1. *Definitions*. For purposes of this CIA:
 - a. an "Ineligible Person" shall include an individual or entity who:
 - i. is currently excluded from participation in any Federal health care program; or
 - ii. has been convicted of a criminal offense that falls within the scope of 42 U.S.C. § 1320a-7(a), but has not yet been excluded.
 - b. "Exclusion List" means the HHS/OIG List of Excluded Individuals/Entities (LEIE) (available through the Internet at http://www.oig.hhs.gov).
- 2. Screening Requirements. South Miami Hospital shall ensure that all prospective and current Covered Persons are not Ineligible Persons, by implementing the following screening requirements.
 - a. South Miami Hospital shall screen all prospective Covered Persons against the Exclusion List prior to engaging their services and, as part of the hiring or contracting process, shall require such Covered Persons to disclose whether they are Ineligible Persons.
 - b. To the extent not already accomplished, South Miami Hospital shall screen all current Covered Persons against the

- Exclusion List within 90 days after the Effective Date and on a monthly basis thereafter.
- c. South Miami Hospital shall implement a policy requiring all Covered Persons to disclose immediately if they become an Ineligible Person.

Nothing in this Section III.G affects South Miami Hospital's responsibility to refrain from (and liability for) billing Federal health care programs for items or services furnished, ordered, or prescribed by an excluded person. South Miami Hospital understands that items or services furnished, ordered, or prescribed by excluded persons are not payable by Federal health care programs and that South Miami Hospital may be liable for overpayments and/or criminal, civil, and administrative sanctions for employing or contracting with an excluded person regardless of whether South Miami Hospital meets the requirements of Section III.G.

- that a Covered Person has become an Ineligible Person, South Miami Hospital shall remove such Covered Person from responsibility for, or involvement with, South Miami Hospital's business operations related to the Federal health care program(s) from which such Covered Person has been excluded and shall remove such Covered Person from any position for which the Covered Person's compensation or the items or services furnished, ordered, or prescribed by the Covered Person are paid in whole or part, directly or indirectly, by any Federal health care program(s) from which the Covered Person has been excluded at least until such time as the Covered Person is reinstated into participation in such Federal health care program(s).
- 4. Pending Charges and Proposed Exclusions. If South Miami Hospital has actual notice that a Covered Person is charged with a criminal offense that falls within the scope of 42 U.S.C. §§ 1320a-7(a), 1320a-7(b)(1)-(3), or is proposed for exclusion during the Covered Person's employment or contract term or during the term of a physician's or other practitioner's medical staff privileges, South Miami Hospital shall take all appropriate actions to ensure that the responsibilities of that Covered Person have not and shall not adversely affect the quality of care rendered to any beneficiary or the accuracy of any claims submitted to any Federal health care program.

H. Notification of Government Investigation or Legal Proceeding

Within 30 days after discovery, South Miami Hospital shall notify OIG, in writing, of any ongoing investigation or legal proceeding known to South Miami Hospital

conducted or brought by a governmental entity or its agents involving an allegation that South Miami Hospital has committed a crime or has engaged in fraudulent activities. This notification shall include a description of the allegation, the identity of the investigating or prosecuting agency, and the status of such investigation or legal proceeding. South Miami Hospital also shall provide written notice to OIG within 30 days after the resolution of the matter and a description of the findings and/or results of the investigation or proceeding, if any.

I. Overpayments

- 1. Definition of Overpayment. An "Overpayment" means any funds that South Miami Hospital receives or retains under any Federal health care program to which South Miami Hospital, after applicable reconciliation, is not entitled under such Federal health care program.
- 2. Overpayment Policies and Procedures. Within 120 days after the Effective Date, South Miami Hospital shall develop and implement written policies and procedures regarding the identification, quantification, and repayment of Overpayments received from any Federal health care program.

J. Reportable Events

- 1. Definition of Reportable Event. For purposes of this CIA, a "Reportable Event" means anything that involves:
 - a. a substantial Overpayment;
 - b. a matter that a reasonable person would consider a probable violation of criminal, civil, or administrative laws applicable to any Federal health care program for which penalties or exclusion may be authorized;
 - c. the employment of or contracting with a Covered Person who is an Ineligible Person as defined by Section III.G.1.a; or
 - d. the filing of a bankruptcy petition by South Miami Hospital.

A Reportable Event may be the result of an isolated event or a series of occurrences.

- 2. Reporting of Reportable Events. If South Miami Hospital determines (after a reasonable opportunity to conduct an appropriate review or investigation of the allegations) through any means that there is a Reportable Event, South Miami Hospital shall notify OIG, in writing, within 30 days after making the determination that the Reportable Event exists.
- 3. Reportable Events under Section III.J.1.a. and III.J.1.b. For Reportable Events under Section III.J.1.a and b, the report to OIG shall include:
 - a. a complete description of all details relevant to the Reportable Event, including, at a minimum, the types of claims, transactions or other conduct giving rise to the Reportable Event; the period during which the conduct occurred; and the names of individuals and entities believed to be implicated, including an explanation of their roles in the Reportable Event;
 - b. a statement of the Federal criminal, civil or administrative laws that are probably violated by the Reportable Event, if any;
 - c. the Federal health care programs affected by the Reportable Event;
 - d. a description of the steps taken by South Miami Hospital to identify and quantify any Overpayments; and
 - e. a description of South Miami Hospital's actions taken to correct the Reportable Event and prevent it from recurring.

If the Reportable Event involves an Overpayment, within 60 days of identification of the Overpayment, South Miami Hospital shall repay the Overpayment, in accordance with the requirements of 42 U.S.C. § 1320a-7k(d) and 42 C.F.R. § 401.301-305 (and any applicable CMS guidance) and provide OIG with a copy of the notification and repayment.

4. Reportable Events under Section III.J.1.c. For Reportable Events under Section III.J.1.c, the report to OIG shall include:

- a. the identity of the Ineligible Person and the job duties performed by that individual;
- b. the dates of the Ineligible Person's employment or contractual relationship;
- c. a description of the Exclusion List screening that South Miami Hospital completed before and/or during the Ineligible Person's employment or contract and any flaw or breakdown in the screening process that led to the hiring or contracting with the Ineligible Person;
- d. a description of how the Ineligible Person was identified; and
- e. a description of any corrective action implemented to prevent future employment or contracting with an Ineligible Person.
- 5. Reportable Events under Section III.J.1.d. For Reportable Events under Section III.J.1.d, the report to OIG shall include documentation of the bankruptcy filing and a description of any Federal health care program requirements implicated.
- 6. Reportable Events Involving the Stark Law. Notwithstanding the reporting requirements outlined above, any Reportable Event that involves solely a probable violation of section 1877 of the Social Security Act, 42 U.S.C. §1395nn (the Stark Law) should be submitted by South Miami Hospital to the Centers for Medicare & Medicaid Services (CMS) through the self-referral disclosure protocol (SRDP), with a copy to the OIG. If South Miami Hospital identifies a probable violation of the Stark Law and repays the applicable Overpayment directly to the CMS contractor, then South Miami Hospital is not required by this Section III.J to submit the Reportable Event to CMS through the SRDP.

IV. SUCCESSOR LIABILITY

In the event that, after the Effective Date, South Miami Hospital proposes to (a) sell any or all of its business, business units, or locations (whether through a sale of assets, sale of stock, or other type of transaction) relating to the furnishing of items or services that may be reimbursed by a Federal health care program, or (b) purchase or establish a new business, business unit, or location relating to the furnishing of items or services that may be reimbursed by a Federal health care program, the CIA shall be binding on the purchaser of any business, business unit, or location and any new

business, business unit, or location (and all Covered Persons at each new business, business unit, or location) shall be subject to the applicable requirements of this CIA, unless otherwise determined and agreed to in writing by OIG.

If, in advance of a proposed sale or a proposed purchase, South Miami Hospital wishes to obtain a determination by OIG that the proposed purchaser or the proposed acquisition will not be subject to the requirements of the CIA, South Miami Hospital must notify OIG in writing of the proposed sale or purchase at least 30 days in advance. This notification shall include a description of the business, business unit, or location to be sold or purchased, a brief description of the terms of the transaction and, in the case of a proposed sale, the name and contact information of the prospective purchaser.

V. IMPLEMENTATION AND ANNUAL REPORTS

A. <u>Implementation Report</u>

Within 180 days after the Effective Date, South Miami Hospital shall submit a written report to OIG summarizing the status of its implementation of the requirements of this CIA (Implementation Report). The Implementation Report shall, at a minimum, include:

- 1. the name, address, phone number, and position description of the Hospital Compliance Officer required by Section III.A, and a summary of other noncompliance job responsibilities the Hospital Compliance Officer may have;
- 2. the names and positions of the members of the Hospital Compliance Committee required by Section III.A;
- 3. the names of the Board members who are responsible for satisfying the Board of Directors compliance obligations described in Section III.A.3;
- 4. the names and positions of the Certifying Employees required by Section III.A.4;
- 5. the written process for Certifying Employees to follow for the purpose of completing the certification described in Section III.A.4;
 - 6. a list of the Policies and Procedures required by Section III.B;

- 7. the Training Plan required by Section III.C.1 and a description of the Board of Directors training required by Section III.C.2 (including a summary of the topics covered, the length of the training, and when the training was provided);
- 8. the following information regarding the IRO(s): (a) identity, address, and phone number; (b) a copy of the engagement letter; (c) information to demonstrate that the IRO has the qualifications outlined in Appendix A to this CIA; and (d) a certification from the IRO regarding its professional independence and objectivity with respect to South Miami Hospital;
- 9. a description of the risk assessment and internal review process required by Section III.E;
 - 10. a description of the Disclosure Program required by Section III.F;
- a description of the Ineligible Persons screening and removal process required by Section III.G;
- 12. a copy of South Miami Hospital's policies and procedures regarding the identification, quantification and repayment of Overpayments required by Section III.I;
- 13. a description of South Miami Hospital's corporate structure, including identification of any parent and sister companies, subsidiaries, and their respective lines of business;
- a list of all of South Miami Hospital's locations (including locations and mailing addresses), the corresponding name under which each location is doing business, and the location's Medicare, state Medicaid, and TRICARE provider number and/or supplier number(s); and
 - 15. the certifications required by Section V.C.

B. Annual Reports

South Miami Hospital shall submit to OIG a report on its compliance with the CIA requirements for each of the five Reporting Periods (Annual Report). Each Annual Report shall include, at a minimum, the following information:

- 1. any change in the identity, position description, or other noncompliance job responsibilities of the Hospital Compliance Officer; a current list of the Hospital Compliance Committee members, a current list of the Board members who are responsible for satisfying the Board of Directors compliance obligations, and a current list of the Certifying Employees;
- 2. the dates of each report made by the Hospital Compliance Officer to the Board (written documentation of such reports shall be made available to OIG upon request);
- 3. the Board resolution required by Section III.A.3, a description of the documents and other materials reviewed by the Board, a copy of the Compliance Program Review Report, if applicable, as well as any additional steps taken, in its oversight of the compliance program and in support of making the resolution;
- 4. a list of any new or revised Policies and Procedures developed during the Reporting Period;
- 5. a description of any changes to South Miami Hospital's Training Plan developed pursuant to Section III.C, and a summary of any Board of Directors training provided during the Reporting Period;
- 6. a complete copy of all reports prepared pursuant to Section III.D and South Miami Hospital's response to the reports, along with corrective action plan(s) related to any issues raised by the reports;
- 7. a certification from the IRO regarding its professional independence and objectivity with respect to South Miami Hospital;
- 8. a description of any changes to the risk assessment and internal review process required by Section III.E, including the reasons for such changes;
- 9. a summary of the following components of the risk assessment and internal review process during the Reporting Period: work plans developed, internal audits performed, corrective action plans developed in response to internal audits, and steps taken to track the implementation of the corrective action plans. Copies of any work plans, internal audit reports, and corrective action plans shall be made available to OIG upon request;

- 10. a summary of the disclosures in the disclosure log required by Section III.F that relate to Federal health care programs, including at least the following information: a description of the disclosure, the date the disclosure was received, the resolution of the disclosure, and the date the disclosure was resolved (if applicable). The complete disclosure log shall be made available to OIG upon request;
- 11. a description of any changes to the Ineligible Persons screening and removal process required by Section III.G, including the reasons for such changes;
- 12. a summary describing any ongoing investigation or legal proceeding required to have been reported pursuant to Section III.H. The summary shall include a description of the allegation, the identity of the investigating or prosecuting agency, and the status of such investigation or legal proceeding;
- 13. a description of any changes to the Overpayment policies and procedures required by Section III.I, including the reasons for such changes;
- 14. a summary of Reportable Events (as defined in Section III.J) identified during the Reporting Period;
- 15. a summary of any audits conducted during the applicable Reporting Period by any Medicare, state Medicaid, and TRICARE program contractor or any government entity or contractor, involving a review of Federal health care program claims, and South Miami Hospital's response/corrective action plan (including information regarding any Federal health care program refunds) relating to the audit findings;
- 16. a description of all changes to the most recently provided list of South Miami Hospital's locations as required by Section V.A.13; and
 - 17. the certifications required by Section V.C.

The first Annual Report shall be received by OIG no later than 60 days after the end of the first Reporting Period. Subsequent Annual Reports shall be received by OIG no later than the anniversary date of the due date of the first Annual Report.

C. Certifications

- 1. Certifying Employees. In each Annual Report, South Miami Hospital shall include the certifications of Certifying Employees required by Section III.A.4;
- 2. Baptist Corporate Vice President and Chief Compliance Officer, Hospital Compliance Officer and Chief Executive Officer. The Implementation Report and each Annual Report shall include a certification by Baptist's Corporate Vice President and Chief Compliance Officer, the Hospital Compliance Officer, and Chief Executive Officer at South Miami Hospital, that:
 - a. to the best of his or her knowledge, except as otherwise described in the report, South Miami Hospital has implemented and is in compliance with all of the requirements of this CIA; and
 - b. he or she has reviewed the report and has made reasonable inquiry regarding its content and believes that the information in the report is accurate and truthful.
- 3. Controller. The first Annual Report shall include a certification by the Controller that, to the best of his or her knowledge, South Miami Hospital has complied with its obligations under the Settlement Agreement: (a) not to resubmit to any Federal health care program payors any previously denied claims related to the Covered Conduct addressed in the Settlement Agreement, and not to appeal any such denials of claims; (b) not to charge to or otherwise seek payment from federal or state payors for unallowable costs (as defined in the Settlement Agreement); and (c) to identify and adjust any past charges or claims for unallowable costs.

D. Designation of Information

South Miami Hospital shall clearly identify any portions of its submissions that it believes are trade secrets, or information that is commercial or financial and privileged or confidential, and therefore potentially exempt from disclosure under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. South Miami Hospital shall refrain from identifying any information as exempt from disclosure if that information does not meet the criteria for exemption from disclosure under FOIA.

NOTIFICATIONS AND SUBMISSION OF REPORTS VI.

Unless otherwise stated in writing after the Effective Date, all notifications and reports required under this CIA shall be submitted to the following entities:

Unless otherwise specified, all notifications and reports required by this CIA shall be made by electronic mail, overnight mail, hand delivery, or other means, provided that there is proof that such notification was received. Upon request by OIG, South Miami Hospital may be required to provide OIG with an electronic copy of each notification or report required by this CIA in addition to a paper copy.

OIG INSPECTION, AUDIT, AND REVIEW RIGHTS VII.

In addition to any other rights OIG may have by statute, regulation, or contract, OIG or its duly authorized representative(s) may conduct interviews, examine and/or request copies of or copy South Miami Hospital's books, records, and other documents and supporting materials, and conduct on-site reviews of any of South Miami Hospital's locations, for the purpose of verifying and evaluating: (a) South Miami Hospital's

compliance with the terms of this CIA and (b) South Miami Hospital's compliance with the requirements of the Federal health care programs. The documentation described above shall be made available by South Miami Hospital to OIG or its duly authorized representative(s) at all reasonable times for inspection, audit, and/or reproduction. Furthermore, for purposes of this provision, OIG or its duly authorized representative(s) may interview any of South Miami Hospital's owners, employees, contractors, and directors who consent to be interviewed at the individual's place of business during normal business hours or at such other place and time as may be mutually agreed upon between the individual and OIG. South Miami Hospital shall assist OIG or its duly authorized representative(s) in contacting and arranging interviews with such individuals upon OIG's request. South Miami Hospital's owners, employees, contractors, and directors may elect to be interviewed with or without a representative of South Miami Hospital present.

VIII. DOCUMENT AND RECORD RETENTION

South Miami Hospital shall maintain for inspection all documents and records relating to reimbursement from the Federal health care programs and to compliance with this CIA for six years (or longer if otherwise required by law) from the Effective Date.

IX. DISCLOSURES

Consistent with HHS's FOIA procedures, set forth in 45 C.F.R. Part 5, OIG shall make a reasonable effort to notify South Miami Hospital prior to any release by OIG of information submitted by South Miami Hospital pursuant to its obligations under this CIA and identified upon submission by South Miami Hospital as trade secrets, or information that is commercial or financial and privileged or confidential, under the FOIA rules. With respect to such releases, South Miami Hospital shall have the rights set forth at 45 C.F.R. § 5.65(d).

X. BREACH AND DEFAULT PROVISIONS

South Miami Hospital is expected to fully and timely comply with all of its CIA obligations.

A. <u>Stipulated Penalties for Failure to Comply with Certain Obligations</u>

As a contractual remedy, South Miami Hospital and OIG hereby agree that failure to comply with certain obligations as set forth in this CIA may lead to the imposition of

the following monetary penalties (hereinafter referred to as "Stipulated Penalties") in accordance with the following provisions.

- 1. A Stipulated Penalty of \$2,500 (which shall begin to accrue on the day after the date the obligation became due) for each day South Miami Hospital fails to establish, implement or comply with any of the following obligations as described in Section III:
 - a. a Hospital Compliance Officer;
 - b. a Hospital Compliance Committee;
 - c. the Board of Directors compliance obligations, and the engagement of a Compliance Expert, the performance of a Compliance Program Review and the preparation of a Compliance Program Review Report, as required by Section III.A.3.;
 - d. the management certification obligations;
 - e. written Policies and Procedures;
 - f. training and education of Covered Persons and Board Members:
 - g. a risk assessment and internal review process;
 - h. a Disclosure Program;
 - i. Ineligible Persons screening and removal requirements;
 - j. notification of Government investigations or legal proceedings;
 - k. policies and procedures regarding the repayment of Overpayments; and
 - 1. reporting of Reportable Events.

- 2. A Stipulated Penalty of \$2,500 (which shall begin to accrue on the day after the date the obligation became due) for each day South Miami Hospital fails to engage and use an IRO, as required by Section III.D, Appendix A, or Appendix B.
- 3. A Stipulated Penalty of \$2,500 (which shall begin to accrue on the day after the date the obligation became due) for each day South Miami Hospital fails to submit a complete Implementation Report, Annual Report or any certification to OIG in accordance with the requirements of Section V by the deadlines for submission.
- 4. A Stipulated Penalty of \$2,500 (which shall begin to accrue on the day after the date the obligation became due) for each day South Miami Hospital fails to submit any Claims Review Report in accordance with the requirements of Section III.D and Appendix B or fails to repay any Overpayment identified by the IRO, as required by Appendix B.
- 5. A Stipulated Penalty of \$1,500 for each day South Miami Hospital fails to grant access as required in Section VII. (This Stipulated Penalty shall begin to accrue on the date South Miami Hospital fails to grant access.)
- 6. A Stipulated Penalty of \$50,000 for each false certification submitted by or on behalf of South Miami Hospital as part of its Implementation Report, any Annual Report, additional documentation to a report (as requested by the OIG), or otherwise required by this CIA.
- 7. A Stipulated Penalty of \$1,000 for each day South Miami Hospital fails to comply fully and adequately with any obligation of this CIA. OIG shall provide notice to South Miami Hospital stating the specific grounds for its determination that South Miami Hospital has failed to comply fully and adequately with the CIA obligation(s) at issue and steps South Miami Hospital shall take to comply with the CIA. (This Stipulated Penalty shall begin to accrue 10 days after the date South Miami Hospital receives this notice from OIG of the failure to comply.) A Stipulated Penalty as described in this Subsection shall not be demanded for any violation for which OIG has sought a Stipulated Penalty under Subsections 1- 6 of this Section.

B. <u>Timely Written Requests for Extensions</u>

South Miami Hospital may, in advance of the due date, submit a timely written request for an extension of time to perform any act or file any notification or report required by this CIA. Notwithstanding any other provision in this Section, if OIG grants the timely written request with respect to an act, notification, or report, Stipulated

Penalties for failure to perform the act or file the notification or report shall not begin to accrue until one day after South Miami Hospital fails to meet the revised deadline set by OIG. Notwithstanding any other provision in this Section, if OIG denies such a timely written request, Stipulated Penalties for failure to perform the act or file the notification or report shall not begin to accrue until three days after South Miami Hospital receives OIG's written denial of such request or the original due date, whichever is later. A "timely written request" is defined as a request in writing received by OIG at least five days prior to the date by which any act is due to be performed or any notification or report is due to be filed.

C. Payment of Stipulated Penalties

- 1. Demand Letter. Upon a finding that South Miami Hospital has failed to comply with any of the obligations described in Section X.A and after determining that Stipulated Penalties are appropriate, OIG shall notify South Miami Hospital of: (a) South Miami Hospital's failure to comply; and (b) OIG's exercise of its contractual right to demand payment of the Stipulated Penalties. (This notification shall be referred to as the "Demand Letter.")
- 2. Response to Demand Letter. Within 10 days after the receipt of the Demand Letter, South Miami Hospital shall either: (a) cure the breach to OIG's satisfaction and pay the applicable Stipulated Penalties or (b) request a hearing before an HHS administrative law judge (ALJ) to dispute OIG's determination of noncompliance, pursuant to the agreed upon provisions set forth below in Section X.E. In the event South Miami Hospital elects to request an ALJ hearing, the Stipulated Penalties shall continue to accrue until South Miami Hospital cures, to OIG's satisfaction, the alleged breach in dispute. Failure to respond to the Demand Letter in one of these two manners within the allowed time period shall be considered a material breach of this CIA and shall be grounds for exclusion under Section X.D.
- 3. Form of Payment. Payment of the Stipulated Penalties shall be made by electronic funds transfer to an account specified by OIG in the Demand Letter.
- 4. Independence from Material Breach Determination. Except as set forth in Section X.D.1.c, these provisions for payment of Stipulated Penalties shall not affect or otherwise set a standard for OIG's decision that South Miami Hospital has materially breached this CIA, which decision shall be made at OIG's discretion and shall be governed by the provisions in Section X.D, below.

D. Exclusion for Material Breach of this CIA

- 1. Definition of Material Breach. A material breach of this CIA means:
 - a. repeated violations or a flagrant violation of any of the obligations under this CIA, including, but not limited to, the obligations addressed in Section X.A;
 - b. a failure by South Miami Hospital to report a Reportable Event, take corrective action, or make the appropriate refunds, as required in Section III.J;
 - c. a failure to respond to a Demand Letter concerning the payment of Stipulated Penalties in accordance with Section X.C; or
 - d. a failure to engage and use an IRO in accordance with Section III.D, Appendix A, or Appendix B.
- 2. Notice of Material Breach and Intent to Exclude. The parties agree that a material breach of this CIA by South Miami Hospital constitutes an independent basis for South Miami Hospital's exclusion from participation in the Federal health care programs. The length of the exclusion shall be in the OIG's discretion, but not more than five years per material breach. Upon a determination by OIG that South Miami Hospital has materially breached this CIA and that exclusion is the appropriate remedy, OIG shall notify South Miami Hospital of: (a) South Miami Hospital's material breach; and (b) OIG's intent to exercise its contractual right to impose exclusion. (This notification shall be referred to as the "Notice of Material Breach and Intent to Exclude.")
- 3. Opportunity to Cure. South Miami Hospital shall have 30 days from the date of receipt of the Notice of Material Breach and Intent to Exclude to demonstrate that:
 - a. the alleged material breach has been cured; or
 - b. the alleged material breach cannot be cured within the 30 day period, but that: (i) South Miami Hospital has begun to take action to cure the material breach; (ii) South Miami Hospital is pursuing such action with due diligence; and (iii) South

Miami Hospital has provided to OIG a reasonable timetable for curing the material breach.

4. Exclusion Letter. If, at the conclusion of the 30 day period, South Miami Hospital fails to satisfy the requirements of Section X.D.3, OIG may exclude South Miami Hospital from participation in the Federal health care programs. OIG shall notify South Miami Hospital in writing of its determination to exclude South Miami Hospital. (This letter shall be referred to as the "Exclusion Letter.") Subject to the Dispute Resolution provisions in Section X.E, below, the exclusion shall go into effect 30 days after the date of South Miami Hospital's receipt of the Exclusion Letter. The exclusion shall have national effect. Reinstatement to program participation is not automatic. At the end of the period of exclusion, South Miami Hospital may apply for reinstatement by submitting a written request for reinstatement in accordance with the provisions at 42 C.F.R. §§ 1001.3001-.3004.

E. <u>Dispute Resolution</u>

- Demand Letter or of its Exclusion Letter, and as an agreed-upon contractual remedy for the resolution of disputes arising under this CIA, South Miami Hospital shall be afforded certain review rights comparable to the ones that are provided in 42 U.S.C. § 1320a-7(f) and 42 C.F.R. Part 1005 as if they applied to the Stipulated Penalties or exclusion sought pursuant to this CIA. Specifically, OIG's determination to demand payment of Stipulated Penalties or to seek exclusion shall be subject to review by an HHS ALJ and, in the event of an appeal, the HHS Departmental Appeals Board (DAB), in a manner consistent with the provisions in 42 C.F.R. § 1005.2-1005.21. Notwithstanding the language in 42 C.F.R. § 1005.2(c), the request for a hearing involving Stipulated Penalties shall be made within 10 days after receipt of the Demand Letter and the request for a hearing involving exclusion shall be made within 25 days after receipt of the Exclusion Letter. The procedures relating to the filing of a request for a hearing can be found at http://www.hhs.gov/dab/divisions/civil/procedures/divisionprocedures.html
- 2. Stipulated Penalties Review. Notwithstanding any provision of Title 42 of the United States Code or Title 42 of the Code of Federal Regulations, the only issues in a proceeding for Stipulated Penalties under this CIA shall be: (a) whether South Miami Hospital was in full and timely compliance with the obligations of this CIA for which OIG demands payment; and (b) the period of noncompliance. South Miami Hospital shall have the burden of proving its full and timely compliance and the steps taken to cure the noncompliance, if any. OIG shall not have the right to appeal to the

DAB an adverse ALJ decision related to Stipulated Penalties. If the ALJ agrees with OIG with regard to a finding of a breach of this CIA and orders South Miami Hospital to pay Stipulated Penalties, such Stipulated Penalties shall become due and payable 20 days after the ALJ issues such a decision unless South Miami Hospital requests review of the ALJ decision by the DAB. If the ALJ decision is properly appealed to the DAB and the DAB upholds the determination of OIG, the Stipulated Penalties shall become due and payable 20 days after the DAB issues its decision.

- 3. Exclusion Review. Notwithstanding any provision of Title 42 of the United States Code or Title 42 of the Code of Federal Regulations, the only issues in a proceeding for exclusion based on a material breach of this CIA shall be whether South Miami Hospital was in material breach of this CIA and, if so, whether:
 - a. South Miami Hospital cured such breach within 30 days of its receipt of the Notice of Material Breach; or
 - b. the alleged material breach could not have been cured within the 30 day period, but that, during the 30 day period following South Miami Hospital's receipt of the Notice of Material Breach: (i) South Miami Hospital had begun to take action to cure the material breach; (ii) South Miami Hospital pursued such action with due diligence; and (iii) South Miami Hospital provided to OIG a reasonable timetable for curing the material breach.

For purposes of the exclusion herein, exclusion shall take effect only after an ALJ decision favorable to OIG, or, if the ALJ rules for South Miami Hospital, only after a DAB decision in favor of OIG. South Miami Hospital's election of its contractual right to appeal to the DAB shall not abrogate OIG's authority to exclude South Miami Hospital upon the issuance of an ALJ's decision in favor of OIG. If the ALJ sustains the determination of OIG and determines that exclusion is authorized, such exclusion shall take effect 20 days after the ALJ issues such a decision, notwithstanding that South Miami Hospital may request review of the ALJ decision by the DAB. If the DAB finds in favor of OIG after an ALJ decision adverse to OIG, the exclusion shall take effect 20 days after the DAB decision. South Miami Hospital shall waive its right to any notice of such an exclusion if a decision upholding the exclusion is rendered by the ALJ or DAB. If the DAB finds in favor of South Miami Hospital, South Miami Hospital shall be reinstated effective on the date of the original exclusion.

4. *Finality of Decision*. The review by an ALJ or DAB provided for above shall not be considered to be an appeal right arising under any statutes or regulations. Consequently, the parties to this CIA agree that the DAB's decision (or the ALJ's decision if not appealed) shall be considered final for all purposes under this CIA.

XI. EFFECTIVE AND BINDING AGREEMENT

South Miami Hospital and OIG agree as follows:

- A. This CIA shall become final and binding on the date the final signature is obtained on the CIA.
- B. This CIA constitutes the complete agreement between the parties and may not be amended except by written consent of the parties to this CIA.
- C. OIG may agree to a suspension of South Miami Hospital's obligations under this CIA based on a certification by South Miami Hospital that it is no longer providing health care items or services that will be billed to any Federal health care program and it does not have any ownership or control interest, as defined in 42 U.S.C. §1320a-3, in any entity that bills any Federal health care program. If South Miami Hospital is relieved of its CIA obligations, South Miami Hospital shall be required to notify OIG in writing at least 30 days in advance if South Miami Hospital plans to resume providing health care items or services that are billed to any Federal health care program or to obtain an ownership or control interest in any entity that bills any Federal health care program. At such time, OIG shall evaluate whether the CIA will be reactivated or modified.
- D. All requirements and remedies set forth in this CIA are in addition to and do not affect (1) South Miami Hospital's responsibility to follow all applicable Federal health care program requirements or (2) the government's right to impose appropriate remedies for failure to follow applicable Federal health care program requirements.
- E. The undersigned South Miami Hospital signatories represent and warrant that they are authorized to execute this CIA. The undersigned OIG signatories represent that they are signing this CIA in their official capacities and that they are authorized to execute this CIA.
- F. This CIA may be executed in counterparts, each of which constitutes an original and all of which constitute one and the same CIA. Electronically-transmitted

APPENDIX A

INDEPENDENT REVIEW ORGANIZATION

This Appendix contains the requirements relating to the Independent Review Organization (IRO) required by Section III.D of the CIA.

A. IRO Engagement

- 1. South Miami Hospital shall engage an IRO that possesses the qualifications set forth in Paragraph B, below, to perform the responsibilities in Paragraph C, below. The IRO shall conduct the review in a professionally independent and objective fashion, as set forth in Paragraph D. Within 30 days after OIG receives the information identified in Section V.A.7 of the CIA or any additional information submitted by South Miami Hospital in response to a request by OIG, whichever is later, OIG will notify South Miami Hospital if the IRO is unacceptable. Absent notification from OIG that the IRO is unacceptable, South Miami Hospital may continue to engage the IRO.
- 2. If South Miami Hospital engages a new IRO during the term of the CIA, that IRO must also meet the requirements of this Appendix. If a new IRO is engaged, South Miami Hospital shall submit the information identified in Section V.A.7 of the CIA to OIG within 30 days of engagement of the IRO. Within 30 days after OIG receives this information or any additional information submitted by South Miami Hospital at the request of OIG, whichever is later, OIG will notify South Miami Hospital if the IRO is unacceptable. Absent notification from OIG that the IRO is unacceptable, South Miami Hospital may continue to engage the IRO.

B. IRO Qualifications

The IRO shall:

- 1. assign individuals to conduct the Claims Review who have expertise in the Medicare, state Medicaid, and TRICARE program requirements applicable to the claims being reviewed;
- 2. assign individuals to design and select the Claims Review sample who are knowledgeable about the appropriate statistical sampling techniques;
- 3. assign individuals to conduct the coding review portions of the Claims Review who have a nationally recognized coding certification and who have maintained this certification (e.g., completed applicable continuing education requirements);

- 4. assign licensed nurses or physicians with relevant education, training and specialized expertise (or other licensed health care professionals acting within their scope of practice and specialized expertise) to make the medical necessity determinations required by the Claims Review; and
- 5. have sufficient staff and resources to conduct the reviews required by the CIA on a timely basis.

C. IRO Responsibilities

The IRO shall:

- 1. perform each Claims Review in accordance with the specific requirements of the CIA;
- 2. follow all applicable Medicare, state Medicaid, and TRICARE program rules and reimbursement guidelines in making assessments in the Claims Review;
- 3. request clarification from the appropriate authority (<u>e.g.</u>, Medicare contractor), if in doubt of the application of a particular Medicare, state Medicaid, and TRICARE program policy or regulation;
 - 4. respond to all OIG inquires in a prompt, objective, and factual manner; and
- 5. prepare timely, clear, well-written reports that include all the information required by Appendix B to the CIA.

D. IRO Independence and Objectivity

The IRO must perform the Claims Review in a professionally independent and objective fashion, as defined in the most recent Government Auditing Standards issued by the U.S. Government Accountability Office.

E. IRO Removal/Termination

1. South Miami Hospital and IRO. If South Miami Hospital terminates its IRO or if the IRO withdraws from the engagement during the term of the CIA, South Miami Hospital must submit a notice explaining (a) its reasons for termination of the IRO or (b) the IRO's reasons for its withdrawal to OIG, no later than 30 days after termination or withdrawal. South Miami Hospital must engage a new IRO in accordance with Paragraph A of this Appendix and within 60 days of termination or withdrawal of the IRO.

OIG Removal of IRO. In the event OIG has reason to believe the IRO does 2. not possess the qualifications described in Paragraph B, is not independent and objective as set forth in Paragraph D, or has failed to carry out its responsibilities as described in Paragraph C, OIG shall notify South Miami Hospital in writing regarding OIG's basis for determining that the IRO has not met the requirements of this Appendix. South Miami Hospital shall have 30 days from the date of OIG's written notice to provide information regarding the IRO's qualifications, independence or performance of its responsibilities in order to resolve the concerns identified by OIG. If, following OIG's review of any information provided by South Miami Hospital regarding the IRO, OIG determines that the IRO has not met the requirements of this Appendix, OIG shall notify South Miami Hospital in writing that South Miami Hospital shall be required to engage a new IRO in accordance with Paragraph A of this Appendix. South Miami Hospital must engage a new IRO within 60 days of its receipt of OIG's written notice. The final determination as to whether or not to require South Miami Hospital to engage a new IRO shall be made at the sole discretion of OIG.

APPENDIX B

CLAIMS REVIEW

- A. <u>Claims Review</u>. The IRO shall perform the Claims Review annually to cover each of the five Reporting Periods. The IRO shall perform all components of each Claims Review.
- 1. Definitions. For the purposes of the Claims Review, the following definitions shall be used:
 - a. <u>Overpayment</u>: The amount of money South Miami Hospital has received in excess of the amount due and payable under Medicare, state Medicaid, or TRICARE program requirements, as determined by the IRO in connection with the Claims Review performed under this Appendix B.
 - b. <u>Paid Claim</u>: A claim submitted by South Miami Hospital and for which South Miami Hospital has received reimbursement from the Medicare, state Medicaid, or TRICARE programs.
 - c. <u>Population</u>: The Population shall be defined as all Paid Claims during the 12-month period covered by the Claims Review. In OIG's discretion, OIG may limit the Population to one or more subset(s) of Paid Claims to be reviewed and shall notify South Miami Hospital and the IRO of its selection of the Population at least 30 days prior to the end of each Reporting Period.

South Miami Hospital, or its IRO on behalf of South Miami Hospital, may submit proposals identifying suggestions for the subset(s) of Paid Claims to be reviewed at least 90 days prior to the end of each Reporting Period. In connection with limiting the Population, OIG may consider (1) proposals submitted by South Miami Hospital or its IRO or (2) information furnished to OIG regarding the results of South Miami Hospital's internal risk assessment and internal auditing. The determination of whether, and in what manner, to limit the Population shall be made at the sole discretion of OIG.

2. Claims *Review Sample*. The IRO shall randomly select and review a sample of 100 Paid Claims (Claims Review Sample). The Paid Claims shall be reviewed based on the supporting documentation available at South Miami Hospital's office or under South Miami Hospital's control and applicable Medicare, state Medicaid and TRICARE program requirements to determine whether the items and services furnished

were medically necessary and appropriately documented and whether the claim was correctly coded, submitted, and reimbursed. For each Paid Claim in the Claims Review Sample that results in an Overpayment, the IRO shall review the system(s) and process(es) that generated the Paid Claim and identify any problems or weaknesses that may have resulted in the identified Overpayments. The IRO shall provide its observations and recommendations on suggested improvements to the system(s) and the process(es) that generated the Paid Claim.

3. *Other Requirements.*

- Supplemental Materials. The IRO shall request all documentation a. and materials required for its review of the Paid Claims in the Claims Review Sample and South Miami Hospital shall furnish such documentation and materials to the IRO prior to the IRO initiating its review of the Claims Review Sample. If the IRO accepts any supplemental documentation or materials from South Miami Hospital after the IRO has completed its initial review of the Claims Review Sample (Supplemental Materials), the IRO shall identify in the Claims Review Report the Supplemental Materials, the date the Supplemental Materials were accepted, and the relative weight the IRO gave to the Supplemental Materials in its review. In addition, the IRO shall include a narrative in the Claims Review Report describing the process by which the Supplemental Materials were accepted and the IRO's reasons for accepting the Supplemental Materials.
- b. Paid Claims without Supporting Documentation. Any Paid Claim for which South Miami Hospital cannot produce documentation shall be considered an error and the total reimbursement received by South Miami Hospital for such Paid Claim shall be deemed an Overpayment. Replacement sampling for Paid Claims with missing documentation is not permitted.
- c. <u>Use of First Samples Drawn</u>. For the purposes of the Claims Review Sample discussed in this Appendix, the first set of Paid Claims selected shall be used (<u>i.e.</u>, it is not permissible to generate more than one list of random samples and then select one for use with the Claims Review Sample).
- 4. Repayment of Identified Overpayments. South Miami Hospital shall repay within 60 days any Overpayment(s) identified by the IRO in the Claims Review Sample, in accordance with the requirements of 42 U.S.C. § 1320a-7k(d) and 42 C.F.R § 401.301-305 (and any applicable CMS guidance) (the "CMS overpayment rule"). If South Miami

Hospital determines that the CMS overpayment rule requires that an extrapolated Overpayment be repaid, South Miami Hospital shall repay that amount at the mean point estimate as calculated by the IRO. South Miami Hospital shall make available to OIG all documentation that reflects the refund of any Overpayment(s) to the payor. OIG, in its sole discretion, may refer the findings of the Claims Review Sample (and any related work papers) received from South Miami Hospital to the appropriate Medicare, state Medicaid, or TRICARE programs for appropriate follow up by that payor.

- B. <u>Claims Review Report</u>. The IRO shall prepare a Claims Review Report as described in this Appendix for each Claims Review performed. The following information shall be included in the Claims Review Report.
 - 1. Claims Review Methodology.
 - a. <u>Claims Review Population</u>. A description of the Population subject to the Claims Review.
 - b. <u>Claims Review Objective</u>. A clear statement of the objective intended to be achieved by the Claims Review.
 - c. <u>Source of Data</u>. A description of (1) the process used to identify Paid Claims in the Population and (2) the specific documentation relied upon by the IRO when performing the Claims Review (e.g., medical records, physician orders, certificates of medical necessity, requisition forms, local medical review policies (including title and policy number), CMS program memoranda (including title and issuance number), Medicare carrier or intermediary manual or bulletins (including issue and date), other policies, regulations, or directives).
 - d. <u>Review Protocol</u>. A narrative description of how the Claims Review was conducted and what was evaluated.
 - e. <u>Supplemental Materials</u>. A description of any Supplemental Materials as required by Section A.3.a., above.
 - 2. Statistical Sampling Documentation.
 - a. A copy of the printout of the random numbers generated by the "Random Numbers" function of the statistical sampling software used by the IRO.
 - b. A description or identification of the statistical sampling software package used by the IRO.

3. Claims Review Findings.

a. Narrative Results.

- i. A description of South Miami Hospital's billing and coding system(s), including the identification, by position description, of the personnel involved in coding and billing.
- ii. A description of controls in place at South Miami Hospital to ensure that all items and services billed to Medicare, state Medicaid, or TRICARE programs are medically necessary and appropriately documented.
- iii. A narrative explanation of the IRO's findings and supporting rationale (including reasons for errors, patterns noted, etc.) regarding the Claims Review, including the results of the Claims Review Sample.

b. Quantitative Results.

- i. Total number and percentage of instances in which the IRO determined that the coding of the Paid Claims submitted by South Miami Hospital differed from what should have been the correct coding and in which such difference resulted in an Overpayment to South Miami Hospital.
- ii. Total number and percentage of instances in which the IRO determined that a Paid Claim was not appropriately documented and in which such documentation errors resulted in an Overpayment to South Miami Hospital.
- iii. Total number and percentage of instances in which the IRO determined that a Paid Claim was for items or services that were not medically necessary and resulted in an Overpayment to South Miami Hospital.
- iv. Total dollar amount of all Overpayments in the Claims Review Sample.
- v. Total dollar amount of Paid Claims included in the Claims Review Sample.
- vi. Error Rate in the Claims Review Sample. The Error Rate shall be calculated by dividing the Overpayment in the

- Claims Review Sample by the total dollar amount associated with the Paid Claims in the Claims Review Sample.
- vii. An estimate of the actual Overpayment in the Population at the mean point estimate.
- viii. A spreadsheet of the Claims Review results that includes the following information for each Paid Claim: Federal health care program billed, beneficiary health insurance claim number, date of service, code submitted (e.g., DRG, CPT code, etc.), code reimbursed, allowed amount reimbursed by payor, correct code (as determined by the IRO), correct allowed amount (as determined by the IRO), dollar difference between allowed amount reimbursed by payor and the correct allowed amount.
- c. Recommendations. The IRO's report shall include any recommendations for improvements to South Miami Hospital's billing and coding system or to South Miami Hospital's controls for ensuring that all items and services billed to Medicare, state Medicaid, or TRICARE programs are medically necessary and appropriately documented, based on the findings of the Claims Review.
- 4. *Credentials*. The names and credentials of the individuals who: (1) designed the statistical sampling procedures and the review methodology utilized for the Claims Review and (2) performed the Claims Review.
